NATIONAL DISASTER MEDICAL SYSTEM TRAINING & SUPPORT

The strength of our nation's public health and medical infrastructure and the capabilities necessary to quickly mobilize a coordinated national response to disasters and emergencies are vital to our national security. ESI develops curriculum and trains Disaster Medical Assistance Teams (DMAT) on key applications used in theater to provide and manage critical patient care.



We trained personnel on the EMR, the standard system used to capture and record patient encounters. Patient safety and critical, life-saving operational decisions are dependent upon effective utilization of the EMR system.



JPATS is the standard system used to track patients throughout the continuum of the patient movement system. Critical in maintaining in-transit visibility, it begins when the patient is identified for movement using the Federal Gov't ESF #8.
